

FOCUS GROUP ON COMANAGEMENT, 2018

- Develop and hone a common vision, terminology, common language, the first step of which should be to agree on a common set of definitions;
- 2) Promote **network** to document, share and analyze fisheries co-management experiences, **promote cooperation** and build synergies between researchers and practitioners;
- 3) Create a **toolkit and training materials** for all potential stakeholders (NGO, Administrations, fishers and scientists); and
- 4) Develop a **shared advocacy strategy** to promote the wider implementation of co-management across Europe and appropriate legal frameworks.

- 1) Hone a common vision, terminology, common language; definition of co-management




